- Services cancelled within 48 hours of the scheduled event may be issued a partial credit at the discretion of the owner (e.g., illness, emergency).
- A substitute instructor or a virtual lesson may be used if the scheduled instructor is unavailable.
- An annual fee of \$35 is due at the time of registration.
- Address concerns or issues which arise **with the owner directly**. There will be no posting on social media of any derogatory comments.
- A 30 (thirty) day notice (sent to: info@ameliamusicstudio.com) is required prior to ending services with AMS. Paid services outside of the 30 day notice will be refunded.
- AMS instructors/contractors are prohibited from engaging in services privately with AMS customers until the instructor's affiliation with AMS has been terminated for a period exceeding one year.
- Students are expected to be on time for lessons and committed to practicing at home. Siblings and friends of the student are not allowed to attend the lesson without obtaining prior permission from the owner.
